House Bill 506 revised multiple sections of Chapter 956 of the Revised Code to revise the law governing high volume dog breeders and other dog-related professionals and facilities. House Bill 166,

commonly known as the FY 2020-2021 Operating Budget, amended sections 956.01, 956.031, 956.051, and 956.20 of the Revised Code. Both House Bills initiated the large number of changes necessary in this proposed rule package.

Rule 901:1-8-03 outlines the microchip requirements for all dogs displayed, offered for sale, delivered, bartered, auctioned, brokered, given away, transferred, or sold by a pet store. The rule is being amended to include dog brokers in the requirement for identification to ensure consistency with paragraph (A)(14) of section 956.03 of the Revised Code.
