Milk haulers, dealers, producers, and processors all must meet the requirements of the rules and pay a \$15 one-time licensing fee to the Department's Dairy Division. As outlined in 917.031, the inspection fees for the Dairy Division shall not exceed 63% of the estimated cost of administering and enforcing Chapter 917 of the Revised Code. Additionally, there are record keeping requirements which require time for employer compliance; however, the machinery used in this industry automatically records this information.
