**Standards of identity.**

Foods processed in a food processing establishment shall meet the generally recognized federal standards of identity specified in 21 C.F.R. Parts ~~136-100~~ through 169 (2017) as follows:

(A) 21 C.F.R. Part 100.122, salt and iodized salt;

(B) 21 C.F.R. Part 102, common or usual name for non-standardized foods;

(C) 21 C.F.R. Part 131, milk and cream;

(D) 21 C.F.R. Part 133, cheeses and related cheese products;

(E) 21 C.F.R. Part 135, frozen desserts;

~~(B)~~(G) 21 C.F.R. Part 137, cereal flours and related products;
