The rules in Chapter 901:3-31 outline regulations concerning the labeling, packaging, preparation, and sale of meat, poultry, and fish products in the state of Ohio. The rules have been proposed to be rescinded as all of the requirements in this Chapter are currently regulated in other parts of the Ohio Administrative Code. Namely, these regulations can also be found in Chapters 901:3-1 and 901:2-1 of the Ohio Administrative Code. Based on this duplication, it was determined that this chapter be rescinded. The rules which are being rescinded are as follows:

OAC Rule 901:3-31-03 also outlines the labeling requirements for meat, poultry, and fish products. The existing regulations mirror the regulations found in 21 C.F.R. 101. These regulations have been adopted in Ohio Administrative Code Chapter 901:3-1 and Chapter 901:6-3. Therefore, in order to avoid duplication, the rules are being rescinded.
