Chapter 901:3-6 of the Ohio Administrative Code regulates farm markets, farmers# markets, and farm product auctions which have registered with the Ohio Department of Agriculture. Pursuant to Ohio Revised Code 3717.22, these regulated areas are exempt from the general retail food establishment requirement so long as they register with the Department. This registration is voluntary however, only through registration is an entity exempt from the retail food establishment licensure. In order to meet this exemption, the regulated areas are only allowed to sell foods that are not potentially hazardous.

OAC 901:3-6-02 outlines sanitation rules and prohibitions regarding food articles at farm markets, farmer#s markets, and farm product auctions. The rule is being amended to make a grammatical change which does not affect the substance of the rule.
