Wash, rinse, and bactericidal treatment.**RULE SUMMARY**

Chapter 901:3-6 of the Ohio Administrative Code regulates farm markets, farmers# markets, and farm product auctions which have registered with the Ohio Department of Agriculture. Pursuant to Ohio Revised Code 3717.22, these regulated areas are exempt from the general retail food establishment requirement so long as they register with the Department. This registration is voluntary however, only through registration is an entity exempt from the retail food establishment licensure. In order to meet this exemption, the regulated areas are only allowed to sell foods that are not potentially hazardous.

OAC 901:3-6-04 outlines the wash, rinse, and bactericidal treatment for utilizes and food contact surfaces at the regulated areas. The rule is being amended to make a stylistic change which should allow for easier comprehension by the regulated community. There are no substantive changes proposed.
