Water supply.**RULE SUMMARY**

Chapter 901:3-6 of the Ohio Administrative Code regulates farm markets, farmers# markets, and farm product auctions which have registered with the Ohio Department of Agriculture. Pursuant to Ohio Revised Code 3717.22, these regulated areas are exempt from the general retail food establishment requirement so long as they register with the Department. This registration is voluntary however, only through registration is an entity exempt from the retail food establishment licensure. In order to meet this exemption, the regulated areas are only allowed to sell foods that are not potentially hazardous.

OAC 901:3-6-06 outlines the water supply requirements for the regulated areas. As a general rule, water provided for handwashing and cleaning must be from a municipal water supply. However, water from a non-municipal water supply may be used however it must be tested annually to determine if it is negative for coliform. No substantive changes have been made.

The regulated areas must have access to running water in order to sanitize their equipment, hands, and food contact surfaces. This usually requires access to a dedicated water line. This may limit the number of locations available for the regulated areas. Cost for compliance varies on the location of the regulated area.
