Definition of approved source has been changed to mean a public water source and a private water source which meet the legal definition for those sources and any other source that has been inspected to the same standards by a qualified person and the water tested and found to comply with the Federal safe drinking standards. The amendment was necessary because neither the state EPA nor the local health department will inspect a water source that does not meet the definition of either a public or a private water source. There are several bottlers which use sources other than those meeting the legal definition of a "private" or "public" source.
