Any apiary may be inspected by either the Department or the county apiarist for any serious bee disease. Should any hive contract a serious bee disease, it will be subject to immediate quarantine. Further, there is a possibility that the entire apiary also be quarantined. Quarantine may result in further costs associated with treatment or destruction of the hive.
