Because the area of the quarantine is relatively small, the overall impact of the quarantine will be relatively insignificant. We believe only three businesses have retail tree sales and not all of their trees will be affected (for example fruit trees are not). We estimate the total impact will be less than \$30,000. The corresponding huge economic loss that could result if this insect is not quarantined and eradicated far outweigh the anticipated impact to the quarantined area.
