The prohibition on movement of host materials or costs of mitigating the pest risk via compliance agreements may be the adverse impact to these stakeholders that are located in Butler County. It is estimated that the impact from the regulation will cause an increase in costs to shippers of logs from Butler County. Mitigation of the pest risk will need to be accomplished. This can require fumigation treatments of regulated articles that would cost an estimated \$30 per log to be exported out of Butler. This is based on the estimated cost of \$1200.00 for fumigation and rental of a container of 40 logs. This is based on figures from Fumigation Services, Inc. and M. Bohlke Veneer Corp.

In order to move a regulated article which originated or transited through a regulated area into the state of Ohio or from the state of Ohio into another state, a person must enter into a compliance agreement with the Ohio Department of Agriculture and have an official phytosanitary certificate from the originating state verifying compliance of the walnut material with the conditions of the compliance agreement. Further the regulated article must be accompanied by records indicating the state and county of origin.
