The terms "auction company" has been replaced by "special auctioneer". Rule requires licensees who advertise an auction to list the auctioneer who will conduct the actual auction. Any advertisement for an estate auction must list the name of the executor of the estate and the probate court in which the estate is docketed and the case number.
