The proposed new rule will require new aquatic devices to have ultraviolet disinfection systems, and a multi-year phase-in for existing devices. The new disinfection systems will provide for a higher level of water quality without the increased use of chemical disinfection systems.

The rule requires that all aquatic devices as regulated by 901:9-1-14(A) to eventually have ultraviolet disinfection systems installed. All new devices constructed after Dec. 31 2011 will be required to have the systems, and existing systems will be phased in over a number of years. A ultraviolet system will not be required in devices that have another treatment process that is capable of producing a 99.9% reduction of cryptospridium.

15. Provide a summary of the estimated cost of compliance with the rule to all directly affected persons. When appropriate, please include the source for your information/estimated costs, e.g. industry, CFR, internal/agency:

Ultraviolet disinfection systems vary in price depending on the size of device being disinfected. Smaller systems cost in the range of one to two thousand dollars, while waterpark level systems that handle multiple pools at one time can reach prices of \$150,000 to \$300,000. However, the cost is being mitigated by requiring immediate installation only for new construction and phasing in existing devices over the next eight years. The most at risk devices, indoor aquatic devices, will have two years, while most outdoor operators will have the full eight years to install the devices. Additionally, operators have the option to use other disinfection systems that provide comparable water quality.

This water standard and the use of ultraviolet disinfection systems has been discussed and approved by a sub-committee of the amusement ride safety council and the council as a whole. Cost concerns of existing operators were alleviated by the both the phase-in period and the option to use different disinfection methods.
