All operators must obtain a license prior to operating a concession which cost \$70 annually. All operators must abide by the specific rules of play for each concession type. All operators must have a sign conspicuously posted which complies with the requirements of OCA 901:9-2-05. The cost of the sign will depend on the type of game but will dramatically fluctuate by certain design choices selected by the operator and the vendor they utilize to create the sign. As a minimum, the Department believes that an operator can comply with the regulations for a minimum of \$30. This sign can be utilized for a significant number of years.

901:9-2-12 paragraph A, section 1 removes the requirement that the target must be level horizontally

901:9-2-12 paragraph A, section 1 removes the requirement that in games where coins are used, in no case shall the coin tossed or pitched be larger than a quarter.

901:9-2-12 paragraph B, section 1 removes the requirement that each and every prize shall have a large enough opening and be so is arranged so that it can be won

901:9-2-12 paragraph B, section 1 removes the requirement that when a target is used for "choice," it must be stated on a sign how a "choice" prize is won.

901:9-2-12 paragraph C, section 1 removes the requirement that the boards on which spots are arranged shall be level and unwarped;

901:9-2-12 paragraph C, section 1 removes the requirement that spots, washers, and coins shall be of contrasting colors.

901:9-2-12 paragraph C, section 1 removes the requirement that the diameter of each and every spot shall be three-sixteenths of an inch greater than the diameter of the washer or coin used to play the game.

901:9-2-12 paragraph C, section 1 removes the requirement that the entire washer or coin shall be in the spot to "win."

901:9-2-12 paragraph C, section 1 removes the requirement that when washers are used, only steel washers shall be used.
