- 123:1-29-02 Review of Performance Evaluation within Agency To limit scope of rule to employees in the service of the State and to allow for electronic signatures.
- 123:1-32-03 Sick Leave Credit and Charge of Sick Leave for Employees of County Offices and State Colleges and Universities – To remove references to county offices.
- 123:1-32-04 Notification of Use of Sick Leave by Employees of County Offices and State Colleges and Universities – To remove reference to county offices from the title of the rule.
- 123:1-32-05 Sick Leave Uses, Evidence of Use, and Abuse for Employees Paid by Warrant of the Director of Budget and Management and Employees of County Offices and State Colleges and Universities – To remove reference to county offices from the title of the rule.

- 123:1-32-06 Inadequate Sick Leave for Employees Paid by Warrant of the Director of Budget and Management and Employees of County Offices and State Colleges and Universities – To remove reference to county offices from the title of the rule.
- 123:1-34-03 Civic Duty Leave To limit the scope of the rule to employees in the service of the State.

- 123:1-41-01 Layoffs To remove references to county offices.
- 123:1-41-12 Order of Displacement To limit the scope of the rule to employee's in the service of the State.
- 123:1-41-13 Layoff Jurisdiction Districts for State Agencies, Boards, Commissions and Independent Institutions – To limit the scope of the rule to "independent institutions" that have employees in the service of the State.
- 123:1-43-01 Overtime To change reference from County Human Services to County Departments of Job and Family Services.
- 123:1-44-02 Religious Observances To remove reference to county office appointing authorities.
- 123:1-46-02 Political Activity of Employees in the Classified Service – To limit the scope of the rule to employees in the service of the State and to revise some of the examples presented in the rule.
- 123:1-47-01 Definition of Terms To include a project appointment within the definition of the term "Intermittent Appointment" and to revise and limit the

references to County Departments of Job and Family Services within the definitions or the terms "Full-time Employee" and "Part-time Employee".
