

## ***PUBLIC HEARING NOTICE***

Pursuant to Ohio Revised Code Section 119.03, notice is hereby given that the Department of Administrative Services intends to conduct a public hearing for the purpose of amending Ohio Administrative Code Sections 123:1-29-01, 123:1-34-03, 123:1-41-12, 123:1-43-01, and 123:1-47-01; and the rescission of Ohio Administrative Code Sections 123:1-7-19 and 123:1-7-27.

The proposed to be amended rules deal with the following subject matter:

- 123:1-29-01    Performance Evaluations – Deals with performance evaluations for classified state employees.
- 123:1-34-03    Civic Duty Leave – Deals with paid civic duty leave for employees in the service of the state in association with jury duty or being subpoenaed to a court proceeding under certain circumstances.
- 123:1-41-12    Order of Displacement for Employees in the Service of the State – Deals with the order of layoff of employees in the service of the state and associated displacement rights for such employees.
- 123:1-43-01    Overtime – Deals with the overtime pay for certain eligible employees, designation of certain positions as overtime exempt under certain circumstances, and the coordination of overtime pay in relationship to holidays worked.
- 123:1-47-01    Definition of Terms – Establishes the definitions for certain terms used in Ohio Administrative Code Chapters 123:1-1 to Ohio Administrative Code Chapter 123:1-47.

The proposed to be rescinded rules deal with the following subject matter:

- 123:1-7-19      Collective Bargaining Classifications for County Departments of Job and Family Services – Establishes a class plan for bargaining unit positions in county departments of Job and Family Services.
- 123:1-7-27      Classifications for County Departments of Job and Family Services – Establishes a class plan for positions in county departments of Job and Family Services.

The Department of Administrative Services shall hold a public hearing on the proposed rule adoptions, amendments, and rescissions on Friday, August 23, 2013, at 9:00 a.m. in Room 2793, on the 27<sup>th</sup> floor of the James A. Rhodes State Office Tower located at 30 East Broad Street, Columbus, Ohio. At this hearing, any person affected by the rules may appear and be heard in person, by the person's attorney, or both, may present the person's position, arguments, or contentions orally or in writing, offer and examine witnesses, and present evidence that tends to show that the rules, if adopted or effectuated, will be unreasonable or unlawful.
