Pursuant to Ohio Revised Code Section 119.03, notice is hereby given that the Department of Administrative Services intends to conduct a public hearing for the purpose of amending Ohio Administrative Code Sections 123:1-37-01 through 123:1-37-12 and 123:1-44-01 through 123:1-44-02.

The rules proposed for amendment deal with the following subject matter:

123:1-37-01	Sets forth the procedures associated with pay supplements.
123:1-37-02	Sets forth the procedures for how pay supplements are computed.
123:1-37-04	Sets forth the procedures and practices in determining whether a classification should receive hazard pay.
123:1-37-06	Sets forth the requirements related to a bilingual pay supplement.
123:1-37-07	Sets forth the parameters for how a temporary working level pay adjustment is administered when an employee is assigned to duties in a higher pay range.
123:1-37-08	Sets forth the requirements and procedures associated with a pay supplement for certain professional achievements.
123:1-37-09	Sets forth the requirements and procedures associated with pay supplements for teachers achieving certain additional education.
123:1-37-10	Sets forth the requirements to designate an employee as a "master teacher" and the associated pay supplement.
123:1-37-11	Sets forth the requirements associated with a pay supplement for special education teachers.
123:1-37-12	Sets forth the requirements for pay supplements associated with teachers with supervisory responsibilities for specific extra-curricular activities.
123:1-44-01	Sets forth the requirements to be eligible to receive holiday compensation, provides that holiday shifting is generally not permitted, and deals with appointments that are effective on a holiday.
123:1-44-02	Sets forth the considerations an appointing authority should consider when dealing with leave requests associated with religious observances and designates the review process for requests the employee believes

were improperly denied.
