

# ***PUBLIC HEARING NOTICE***

Pursuant to Ohio Revised Code Section 119.03, notice is hereby given that the Department of Administrative Services intends to conduct a public hearing for the purpose of adopting Ohio Administrative Code Sections 123:1-10-01 and 123:1-21-02; rescinding Ohio Administrative Code Sections 123:1-10-01, 123:1-10-02, 123:1-21-02, 123:1-21-03, and 123:1-21-04; and amending Ohio Administrative Code Sections 123:1-17-04, 123:1-21-01, 123:1-23-02, 123:1-25-01, 123:1-25-04; 123:1-31-01, 123:1-41-07, 123:1-41-11, 123:1-41-12, and 123:1-47-01.

The proposed to be adopted rules deal with the following subject matter:

123:1-10-01 - Eligibility for permanent classified service.

123:1-21-02 - Temporary appointments.

The proposed to be rescinded rules deal with the following subject matter:

123:1-10-01 - Eligibility for automatic certification.

123:1-10-02 - Failure to comply with examination requirements.

123:1-21-02 - Provisional appointments.

123:1-21-03 - Suspension of competition requirements.

123:1-21-04 - Emergency Appointments.

The proposed to be amended rules deal with the following subject matter:

123:1-17-04 - Notice.

123:1-21-01 – Appointment when no eligible list exists.

123:1-23-02 - Promotion without competition.

123:1-25-01 - Transfers and intra-transfers in classified service.

123:1-25-04 - Seasonal positions.

123:1-31-01 - General procedure for removals, reductions, fines, or suspensions.

123:1-41-07 - Order of layoff of employees.

123:1-41-11 - Displacement and appeal rights of employees.

123:1-41-12 - Order of displacement.

123:1-47-01 - Definitions.

These rules are being adopted, rescinded, and amended to take into account changes to the civil service system as a result of the enactment of HB 187 by the 126<sup>th</sup> General Assembly of the State of Ohio.

The Department of Administrative Services shall hold a public hearing on the proposed rule adoptions, rescissions, and amendments on Tuesday, May 15, 2007, at 9:00 a.m. the Lobby Hearing Room of the James A. Rhodes State Office Tower located at 30 East Broad Street, Columbus, Ohio. At this hearing, any person affected by the rule(s) may appear and be heard in person, by the person's attorney, or both, may present the person's position, arguments, or contentions orally or in writing, offer and examine witnesses, and present evidence that tends to show that the rule(s), if adopted or effectuated, will be unreasonable or unlawful.
