The reason for adopting these rules is to comply with section 1513.02 (A)(8) of the Revised Code, created by HB 443 of the 126th General Assembly, which states that the Chief of the Division of Mineral Resources Management shall: "Establish programs and adopt rules and procedures governing terms, limitations, and conditions for the use of diesel equipment in an underground coal mine."

A public hearing on the proposed rules will be held at 9:00 a.m. on Wednesday, September 14, 2011; at the Ohio Department of Natural Resources; Division of Mineral Resources Management; 2045 Morse Road; Building H-2 Conference Room; Columbus, Ohio 43229. At the public hearing, any person affected by the proposed rules may appear and be heard in person, or by their attorney, or both, and may present testimony, orally or in writing, offer and examine witnesses, and present evidence tending to show that the proposed rules, if adopted, will be unreasonable or unlawful.
