NOTICE OF INTENTION TO AMEND AND HOLD A PUBLIC HEARING ON DIVISION OF PARKS AND WATERCRAFT RULES IN CONJUNCTION WITH A DIVISION OF NATURAL AREAS AN PRESERVES RULE

The Ohio Department of Natural Resources, in accordance with sections 1517.02 and 1546.04 of the Ohio Revised Code, hereby gives notice of intention to amend the following rules:

- Administrative rule 1501:17-5-04 is being amended to incorporate, by reference, the definition of "service animal" established under the provisions of the Americans with Disabilities Act.
- Administrative rule 1501:46-2-29 is being amended to set the administrative fee for special activities permits at \$50, to allow the division to charge a fee of not more than \$5,000 for large-scale events, and to update the references to the Revised Code that provide the division rule adoption authority.
- Administrative rule 1501:46-1-03 is being amended to add Jesse Owens state park to the list of areas administered by the Division of Parks and Watercraft.
- Administrative rule 1501:47-3-11 is being amended to correct a reference to Administrative Code 1501:46.
- Administrative rule 1501:47-5-03 is being amended for uniformity with Administrative Code 1501:31.
- Administrative rules 1501:46-2-07, 1501:46-2-37, 1501:46-3-26, 1501:46-5-01, 1501:46-11-20, 1501:47-3-13, 1501:47-3-14, 1501:47-3-15 are being amended to update the references to the Revised Code that are implemented or amplified by the rule and references that provide the Division of Parks and Watercraft with the authority to adopt rules; no changes to the existing rule language are being proposed.

A public hearing on the proposed amendments, adoptions, and rescission of these rules will be held at 2:00 pm on Thursday, May 17th 2018 in the Poverty Meeting Room on the first floor of building C at the Department of Natural Resources located at 2045 Morse Road in Columbus, Ohio. At the public hearing, any person affected by these rule proposals may appear and be heard in person, or by an attorney, or both, and may present testimony, orally or in writing, and present evidence tending to show that these rules, if adopted, amended, or rescinded, will be unreasonable or unlawful.
