## **NOTICE**

Notice is hereby given that the Ohio Department of Aging (ODA) will conduct a public hearing in accordance with section 119.03 of the Ohio Revised Code to obtain comments concerning ODA's proposed rescission of current rules, amendment of current rules, and adoption of new rules of Chapter 173-35 of the Administrative Code that would pertain to the **Residential State Supplement** program.

Pursuant to section 119.032 of the Revised Code, which requires every state agency to review its rules every five years, pursuant to the amendment of section 173.35 of the Revised Code and the enactment of section 173.351 of the Revised Code, as amended by Am. Sub. H. B. № 119 (126<sup>th</sup> G. A.), and pursuant to uncodified section 213.20 of Am. Sub. H. B. № 119 (126<sup>th</sup> G. A.), ODA has filed Chapter 173-35 of the Administrative Code for a formal review by the Joint Committee on Agency Rule Review. As part of that review, ODA is taking this opportunity to reorganize the content of these rules. Therefore, ODA is proposing to rescind rules 173-35-01, 173-35-02, 173-32-03, 173-35-04, 173-35-05, and 173-35-06 of the Administrative Code and simultaneously proposing to replace them with proposed new rules 173-36-01, 173-35-02, 173-35-03, 173-35-04, and 173-35-05 of the Administrative Code. ODA is also proposing to amend rule 173-35-07 of the Administrative Code.
