Changes to these rules include the addition of definitions to provide additional clarity, addition of timelines and deadlines, and deletion of provisions that are no longer necessary.

Changes to the rules include differentiation of the process for initial and reissue of school charters, expansion of the timeframe to submit an application, clarification of language to determine compliance with the Operating Standards, addition of language for monitoring of schools, addition of language that allows the Department to follow up with a school that is no longer accredited to ensure compliance with the Operating Standards, addition of language that gives a school the ability to utilize a corrective action, and a process specifying for a school to address deficiencies.

Changes to these rules include addition of language to align with the rules for the Jon Peterson scholarship program, to remove and revise language in accordance with Section ORC 106.03, to differentiate between a school providing all services to students versus a school or provider providing only the education program or related services, and to adjust deadlines to be more accommodating for families.
