

NOTICE OF PUBLIC HEARING

The Ohio Facilities Construction Commission (OFCC), pursuant to Chapter 119 of the Ohio Revised Code, hereby gives notice that a public hearing will be conducted for the purpose of considering the adoption of the following rules contained in the Ohio Administrative Code.

The public hearing will be conducted on **Friday, December 8, 2017**, beginning at **10:00 a.m.** in **L-2 Room 1**, located at the William Green Building, **30 W. Spring Street, Floor 2, Columbus, OH 43215**. All interested parties affected by the proposed rules may be heard by oral or written testimony.

The following new rules are being proposed:

Rule Number & Action	Rule Name and Summary
3318-1-01 Amend	<u>Commission members.</u> This rule defines the composition of the Commission. The Commission shall consist of seven members, three of whom are voting members. Four are non-voting members of the legislature (two each from the House and Senate and each will be of different political parties)
3318-1-02 Amend	<u>Commission meetings.</u> This rule requires a quorum of the Commission be two voting members and the order of business for regular meetings of the Commission.
3318-2-04 Amend	<u>Confidentiality status.</u> This rule includes medical records as part of an employee's personal confidential information.
3318:1-2-01 Rescind	<u>Accessing personal confidential information: Definitions</u> This rule is reflected in OFCC rules
3318:1-2-02 Rescind	<u>Procedure for accessing personal confidential information.</u> This rule is reflected in OFCC rules
3318:1-2-03 Rescind	<u>Valid reason for accessing confidential personal information.</u> This rule is reflected in OFCC rules
3318:1-2-04 Rescind	<u>Confidentiality statutes.</u> This rule is reflected in OFCC rules
3318:1-2-05 Rescind	<u>Restricting and logging access to confidential personal information in computerized information systems.</u> This rule is reflected in OFCC rules
