

# NOTICE OF PUBLIC RULES HEARING

In accordance with Chapter 119. of the Revised Code (R.C.), the Director of the Department of Health (Director) announces a Public Hearing at the date and time listed above to hear comments regarding the following actions:

## **O.A.C. Chapter 3701-27 – Manufactured Home Parks.**

Ohio Administrative Code 3701-27-01 to 3701-27-30 governed the licensing and inspection of Manufactured Home Parks. The Director is proposing rescission of the entire chapter due to legislation enacted in 2012 that moved authority to regulate Manufactured Home Parks to the Ohio Manufactured Homes Commission. As a result of the legislation, the applicable regulation is currently codified under O.A.C. Chapter 4781-12 and rescission of the rules is proposed to bring state regulation in line with the statute.

## **O.A.C. Chapter 3701:1-49 – Radioactive Material Standards – Well Logging.**

By authority of R.C. 3748.04 and to satisfy five-year review requirements, the Director proposes to amend O.A.C. Rules 3701:1-49-08, 3701:1-49-10, and 3701:1-49-11 pertaining to Radioactive Material Standards – Well Logging. Only minor upkeep changes are proposed to these rules: 1) a change of bureau name; and 2) replacement of “semi-annual” with “intervals not to exceed six months.” The remainder of the Chapter 3701:1-48 rules will be proposed without change and will not be considered at this public hearing.

## **Procedure and Public Comment:**

At the hearing, people affected by the proposed actions may appear and be heard in person, by an attorney or both; may present their positions, arguments, or contentions orally or in writing; may offer witnesses; and may present evidence tending to show that the proposed rules, if adopted or effectuated, will be unreasonable or unlawful.
