

NOTICE OF PUBLIC RULES HEARING

In accordance with Chapter 119. of the Revised Code (R.C.), the Director of the Department of Health (Director) announces a Public Hearing at the date and time listed above to hear comments regarding the following actions:

O.A.C. Chapter 3701-61 – Residents’ Rights on Transfer or Discharge; Employee Background Checks.

By authority of R.C. 3721.11 and to satisfy five-year review requirements, the Director proposes to amend O.A.C. Rules 3701-61-01, 3701-61-02, 3701-61-04, and 3701-61-06 pertaining to Resident’s Rights on Transfer and Discharge and Employee Background Checks. These rules are amended to make cross-citation updates, and to add dates to cited material for clarification purposes.

O.A.C. Chapter 3701:1-46 – General Licenses and Licenses for Manufacturing and Distribution of Radioactive Material.

By authority of R.C. 3748.04 and to satisfy five-year review requirements, the Director proposes to amend O.A.C. Rules 3701:1-46-01, 3701:1-46-10, 3701:1-46-36, and 3701:1-46-43 pertaining to General Licenses and Licenses for Manufacturing and Distribution of Radioactive Material. Only minor upkeep changes are proposed to these rules: 1) the removal of an unneeded definition; 2) spelling out the acronym “USNRC” to the “United States Nuclear Regulatory Commission”; and 3) the correction of misspellings and a rule reference. The remainder of the Chapter 3701:1-46 rules will be proposed without change and will not be considered at this public hearing.

Previously Announced Rules on 5/4/2017 Agenda are from: O.A.C. Chapter 3701-27 (Manufactured Home Parks), and Chapter 3701:1-49 – Radioactive Material Standards – Well Logging).

Procedure and Public Comment:

At the hearing, people affected by the proposed actions may appear and be heard in person, by an attorney or both; may present their positions, arguments, or contentions orally or in writing; may offer witnesses; and may present evidence tending to show that the proposed rules, if adopted or effectuated, will be unreasonable or unlawful.
