In accordance with Chapter 119. of the Revised Code (R.C.), the Director of the Department of Health (Director) announces a Public Hearing at the date and time listed above to consider the following draft rules:

O.A.C. Chapter 3701-13 – Direct Care Providers – Criminal Records Check of Employees

Pursuant to R.C. 3701.34 and 3712.09 and to satisfy five-year review (FYR) requirements, the Director proposes to amend O.A.C. rules 3701-13-01 and 3701-13-03. The proposed rules provide chapter definitions (rule 3701-13-01) and set requirements for criminal records checks of all applicants under final consideration for employment by direct care providers (3701-13-03). At JCARR's recommendation, the no change filing of these two rules was withdrawn and the rules are now proposed as amended to update cross-citations in the rules.

O.A.C. Rules 3701-17 - Nursing Homes

Pursuant to R.C. 3721.04 and to satisfy FYR requirements, the Director proposes the following actions concerning nursing home rules: To amend O.A.C. 3701-17-01, -03, -05, -07, -07.1, -07.2, -08, -10, -12, -14, -15, -16, -18, -19, -21, -23, -24, -25, and -26; and to rescind current and propose new rules 3701-17-06, and 3701-17-09. Major highlights include the re-writing of rules 3701-17-06 (quality and performance improvement), 3701-17-09 (resident life enrichment rule [formerly social services]), rule 3701-17-18 (food and dining), and rule 3701-17-14 (resident care planning), and the inclusion of carbon monoxide standards in rule 3701-17-25

Procedure and Public Comment:

At the hearing, people affected by the proposed actions may appear and be heard in person, by an attorney or both; may present their positions, arguments, or contentions orally or in writing; may offer witnesses; and may present evidence tending to show that the proposed rules, if adopted or effectuated, will be unreasonable or unlawful.
