

**NOTICE OF PUBLIC RULES HEARING**

In accordance with Chapter 119 of the Revised Code (R.C.) and by authority of R.C. 3717.04 and 3717.05, the Public Health Council (PHC) jointly with the Director of the Department of Agriculture (ODA) will conduct a public hearing at the place and time listed above for the purpose of amending the following Ohio Uniform Food Safety Code rules: 3717-1-01, 3717-1-02, 3717-1-02.1, 3717-1-02.2, 3717-1-02.4, 3717-1-03.1, 3717-1-03.2, 3717-1-03.3, 3717-1-03.4, 3717-1-03.5, 3717-1-03.7, 3717-1-04, 3717-1-04.1, 3717-1-04.2, 3717-1-04.2, 3717-1-04.4, 3717-1-04.5, 3717-1-04.6, 3717-1-04.8, 3717-1-05, 3717-1-05.2, 3717-1-06.2, 3717-1-06.4, 3717-1-07.1, 3717-1-08, 3717-1-08.3, and 3717-1-09.

The Ohio Uniform Food Safety Code provides the standards for safe food handling and sanitation in retail food establishments and food service operations. The Code is based upon the Federal Food and Drug Administration (FDA) Model Food Code that was updated in November 2009 and September 2011. The proposed changes were recommended for adoption by the Retail Food Safety Advisory Council, and they consist of updates from the FDA Code, corrections of typos and punctuation errors, and the addition of new language regarding micro markets. The new micro markets language is proposed to accommodate Ohio's vending industry.

At the hearing, people affected by the proposed rules may appear and be heard in person, by an attorney, or both; may present their positions, arguments, or contentions orally or in writing; may offer witnesses; and may present evidence tending to show that the proposed rules, if adopted or effectuated, will be unreasonable or unlawful.
