In accordance with Chapter 119 of the Revised Code (R.C.), the Director (Director) of the Ohio Department of Health (ODH), or his designee, shall conduct a public rules hearing at the date, time, and place listed above. The hearing will consider changes to the following Ohio Administrative Code (O.A.C.) rules:

### O.A.C. 3701-43 – Medically Handicapped Children

These BCMH rules are proposed by authority of R.C. 3701.021 and to satisfy five-year review requirements. The rules pertain to the operation and administration of the benefit program Children with Medical Handicaps, contained within the Bureau for Children with Developmental and Special Health Needs.

### Some proposed changes include:

In 3701-43-01, the elimination of the ability to have provisional sub-specialty status with CMH program based solely on letter of recommendation from the chief of services of the sub-specialty area in a hospital;

In 3701-43-05, the elimination of the ability of physician who solely is a neurodevelopmental disabilities or developmental-behavorial pediatrician, or a pediatrician who is a member of a program-approved multi-disciplinary team to approve orthotic, prosthetic or wheelchair services; and

In rules 3701-43-18 and 3701-43-23, the correction of citation errors.

Finally, new rule 4701-43-26 is proposed to allow manufacturers of prescription drugs and nutritional formulas to provide the Ohio Department of Health with a discount on CMH approved formulary prescription drugs and nutritional formulas. Rule 3701-43-26 is proposed pursuant to House Bill 153 of the 129<sup>th</sup> General Assembly.

# OAC 3701:1-40-09 – Radiation Protection Requirements: Certain items containing radioactive material

The Director is proposing to amend this rule pursuant to Revised Code 3748.02 and 3748.04 and to satisfy five-year review requirements. Proposed changes make minor changes for consistency in units, and add products containing small quantities of radioactive material that are exempt from licensing requirements, unless a person desires to apply radioactive material to, or to incorporate radioactive material into, the exempt products.

### O.A.C. 3717-1-01 – State of Ohio Uniform Food Safety Code and Definitions

Pursuant to Ohio Administrative Code 3717.04 and 3717.05, the Directors of the Department of Health and the Department of Agriculture jointly propose to amend O.A.C. Rule 3717-1-01. The proposed amendment changes the definition of "micro markets" to allow this type of operation to offer additional food items.

### **Hearing and Comment Procedure:**

At the hearing, people affected by the proposed actions may appear and be heard in person, by an attorney or both; may present their positions, arguments, or contentions orally or in writing; may offer witnesses; and may present evidence tending to show that the proposed rules, if adopted or effectuated, will be unreasonable or unlawful.
