The Ohio Department of Public Safety, Bureau of Motor Vehicles ("BMV"), will conduct a public hearing for the purpose of soliciting comments regarding proposed changes to Chapter 4501:1-3, "Motor Vehicle Dealers and Salespersons," of the Ohio Administrative Code. These changes are proposed to address materials incorporated by reference in compliance with sections 121.71 to 121.74 of the Revised Code.

Rule 4501:1-3-03 (Sign required to identify place of business) requires a business sign with the name of the dealership to be prominently displayed. This rule is proposed for amendment to update the dates of publication for materials incorporated by reference in compliance with sections 121.71 to 121.74 of the Revised Code.

Rule 4501:1-3-07 (Law enforcement report required with application) establishes that an owner, officer of a corporation, or trustee of a business applying for a dealer's license shall furnish a complete report from local law enforcement agencies checked on a state-wide basis through the bureau of criminal investigations. This rule is proposed for amendment to update the titles and dates of publication for materials incorporated by reference in compliance with sections 121.71 to 121.74 of the Revised Code.

Rule 4501:1-3-09 (Registrar shall deny license) requires the BMV registrar to deny an application if the applicant has been convicted of a felony related to the selling, taxing, licensing, or regulation of sales of motor vehicles that occurred within ten years of the date of application. This rule is proposed for amendment to update the titles and dates of publication for materials incorporated by reference in compliance with sections 121.71 to 121.74 of the Revised Code.

Persons affected by the proposed rules may appear at the hearing and be heard in person, or by an attorney, or both, or may present their position, argument, or contention in writing. Persons may offer and examine witnesses and present evidence to show that the proposed rules will be unreasonable or unlawful if enacted.
