

NOTIFICATION OF PUBLIC HEARING

Notice of hearing
to amend Rules 4501:2-10-01 through 4501:2-10-11,
to rescind Rule 4501:2-10-13, and
to adopt new Rules 4501:2-10-13 and 4501:2-10-14
of the Ohio Administrative Code in accordance with
Chapter 119. of the Ohio Revised Code

Notice is hereby given that a hearing will be held by the Ohio Highway Patrol Division of the Ohio Department of Public Safety for the purpose of considering the proposed amendment, rescission, and adoption of the above-listed administrative rules.

As authorized in Section 5503.10 of the Ohio Revised Code, the Ohio Highway Patrol Division of the Ohio Department of Public Safety proposes to amend Rules 4501:2-10-01 through 4501:2-10-11, to rescind Rule 4501:2-10-13, and to adopt new Rules 4501:2-10-13 and 4501:2-10-14 of the Ohio Administrative Code. These rules govern the Law Enforcement Automated Data System known as LEADS. Proposed changes are to update, simplify, and enhance the clarity and usefulness of these administrative rules.

Proposed changes include updating to include provision for enhancement of LEADS via requirements and restrictions necessary for connection to the databases and resources of INTERPOL by authorized law enforcement authorities, provision regarding requirements for access to FBI criminal history record information (CHRI) by governmental social service agencies with child protection responsibilities as provided for in the Adam Walsh Child Protection and Safety Act of 2006, provision for revision and consolidation of agreement forms to adequately reflect current needs in a user-friendly format, provision to reflect a change in the system name from "National law enforcement telecommunications system (NLETS)" to the "NLETS (International justice and public safety information sharing network)", provision for removal of unnecessary verbiage, provision for clarification of the consequences of failure to comply with LEADS records validation requirements, provision for replacement of terminology and other rule language with updated and/or clarifying language, and provision for grammatical change.

A public hearing on the proposed rules will be held Thursday, January 3, 2008 at 10:00 a.m. in room 109 (first floor) of the Charles D. Shipley Building, Ohio Department of Public Safety, 1970 West Broad Street, Columbus, Ohio.

Either written or oral testimony will be received at the hearing. Additionally, written comments received at the address below before the hearing will be treated as testimony.
