NOTICE OF PUBLIC HEARING

The Ohio State Dental Board will hold a Public Hearing on March 22, 2023 at 9:30 a.m. in the Vern Riffe Center for the Government and the Arts, 77 S. High St., 17th Floor, Dental Board Conference Room, Columbus, Ohio for the purpose of adopting the following administrative rules.

Rule Number	Rule Title	Synopsis of Proposed Rule
4715-3-01 - Amended	Definitions	The rule sets the definitions used by the Board which includes terms for advertising, sedation, prescribing, and personnel, etc. Amendments have been proposed to add new definitions, update sedation definitions, and reorganize rule language.
4715-5-05 – Rescind	Use of general anesthesia and deep sedation.	The Board is rescinding this rule and making it a new rule due to being over the 50% amendment threshold.
4715-5-05 – New	Use of general anesthesia and deep sedation.	The new rule replaces rescinded rule 4715-5-05 and sets forth the Board’s specific guidelines for the application of a permit and the use of general anesthesia by licensed dentists.
4715-5-06 – Amended	Reports of adverse occurrences.	The rule sets forth the specific requirements for an office to report an adverse occurrence. The amendment to this rule is to clarify adverse occurrence, clarify the timeframe, and update the permit name.
4715-5-07 - Rescind	Use of conscious sedation.	The Board is rescinding this rule and making it a new rule due to being over the 50% amendment threshold.
4715-5-07 – New	Use of moderate sedation.	The new rule replaces rescinded rule 4715-5-07 and sets forth the Board’s specific guidelines for the application of a permit and the use of moderate sedation by licensed dentists

Any person affected by the proposed rules may appear and be heard in person, through his/her attorney, or both; may present his/her position arguments, or contentions, orally or in writing; offer and examine witnesses; and present evidence tending to show that the amendments, if effectuated, will be unreasonable and unlawful.

A copy of the full text of said amended rules have been filed with the Secretary of State, Legislative Service Commission, and the Joint Committee on Agency Rule Review at least thirty days prior to the date set for the hearing and a copy of the amended rules are available in printed form at the office of the Ohio State Dental Board, 77 S.
