The Ohio Board of Nursing (Board) will conduct a public hearing on the fourth floor, Suite 400, at 17 South High Street, Columbus, OH, on Wednesday, November 20, 2002 beginning at 10:00 a.m. and continuing until all parties in attendance have had an opportunity to be heard.
