## NOTICE OF PUBLIC HEARING

The OHIO VETERINARY MEDICAL LICENSING BOARD, pursuant to Chapter 119. of the Ohio Revised Code, hereby gives notice that it will conduct a public hearing for the purpose of its five-year rule review and consider changes to the rules governing the practice of veterinary medicine. The hearing will be held on Wednesday, September 12, 2007 at the Riffe Center, 31<sup>st</sup> Floor Board room, 77 South High Street, Columbus, OH 43215 beginning at 8:30 a.m.

The Board is proposing to amend the following existing rules: 4741-1-01, Animal technician duties, registration and continuing education requirements; 4741-1-02, Specialist; 4741-1-04, Examination; 4741-1-05, Prescribing, administering, and dispensing of drugs; 4741-1-06, Method of giving public notice; 4741-1-07, Approved veterinary and animal technology colleges; 4741-1-09, Treatment or euthanasia of animals; 4741-1-11, Form and content of continuing education hours; 4741-1-12, Embryo transfer: definition and practice; 4741-1-19, Veterinary student; 4741-1-21, Record keeping rule; 4741-1-22, Vaccination clinics; and 4741-1-23, Euthanasia technician certification course curriculum.

The Board is proposing to rescind the following rules: 4741-1-03, Minimum standards of sanitary and hygienic methods to be used in the humane care and treatment of animals; 4741-1-13, Animal technology schools approved by the board; and 4741-1-16, Register of colleges.

The Board is proposing to adopt the following new rules: 4741-1-03, Minimum standards for stationary veterinary facilities; 4741-1-08, Mobile veterinary practices and mobile veterinary practice facilities; 4741-2-01, General provisions of veterinary business facility license; 4742-2-02, Change of control; 4741-2-03, Limited licensure; 4741-2-04, Temporary permit to practice; 4741-3-01, Purpose of the veterinary student loan repayment program; 4741-3-02, Definitions; 4741-3-03, Veterinary resource shortage area; 4741-3-04, Criteria for prioritizing underserved areas; and 4741-3-05, Criteria for selection of applicants.
