# **NOTICE OF PUBLIC HEARING**

The hearing will take place in the **Board Room** and continue until all parties in attendance have had an opportunity to be heard.

Oral or written testimony may be presented by any person affected by the proposed action.

#### The following rules are being proposed as amended rules:

## 4747-1-02: Definitions and interpretations

This rule sets forth the definitions for hearing aid dealing and fitting. The Board is amending the definitions to align with the FDA's regulations for over-the-counter hearing aids and prescription hearing aids.

### 4747-1-19: Appropriate hearing test procedures

This rule sets forth the requirements for appropriate hearing test procedures for hearing aid fitters. The Board is amending this rule to align with the FDA's regulations for over-the-counter hearing aids and prescription hearing aids.

### 4753-3-05: Student clinical experience

This rule specifies the requirements for individuals completing the student clinical experience requirements for speech-language pathology or audiology in a graduate level program. The Board is amending this rule to no longer require a notarized signature from the university program director verifying that the student completed their student clinical experience. The Board will accept the signature on the university's letterhead.

#### 4753-8-01: Definitions

The rule sets forth the definitions for hearing aids, dispensing hearing aids, and advertising of hearing aids for audiologists licensed under Chapter 4753. The Board is amending definitions to align with FDA's regulations for over-the-counter hearing aids and prescription hearing aids.

## 4753-8-03: Rules on appropriate hearing aid test procedures;

This rule sets forth the requirements for appropriate hearing test procedures for audiologists. The Board is amending hearing test procedures to align with FDA's regulations for over-the-counter hearing aids and prescription hearing aids
