NOTICE OF PUBLIC HEARING

The State of Ohio Counselor, Social Worker, & Marriage and Family Therapist Board, pursuant to Ohio Revised Code Chapter 119, hereby gives notice that it will conduct a public hearing for the purpose of considering amendments to the following rules:

- 4757-1-05 License fees.
- 4757-3-01 Definitions
- 4757-5-03 Standards of ethical practice and professional conduct: multiple relationships.
- 4757-5-10 Standards of ethical practice and professional conduct: reporting unethical actions.
- 4757-5-13 Standards of practice and professional conduct: electronic service delivery (internet, email, teleconference, etc.).
- 4757-9-01 Continuing education requirements for renewal of a MFT or IMFT license.
- 4757-13-01 Education requirements for admission to the examination for LPC.
- 4757-13-07 Counselor program approval.
- 4757-17-01 Counseling supervision.
- 4757-25-01 Education requirements for admission to the examination for a MFT.
- 4757-25-02 Marriage and family therapist examination policy.
- 4757-29-01 Marriage and family therapy supervision.

The public hearing on the proposed actions of the Counselor, Social Worker & Marriage and Family Therapist Board is scheduled for Monday, June 17. The hearing will begin at 1:00 PM. in the Addams Conference Room, Room 2468, 24th floor, Riffe State Office Tower, 77 South High Street, Columbus, Ohio, 43215, and from time to time thereafter as may be required by the Board to hear all relevant testimony, oral or written, by any person affected by the proposed action, his/her attorney, or both.

Those persons who wish to provide oral testimony at the hearing are encouraged to inform the Board prior to the hearing date and may be given preference in the order of their testimony. Copies of the proposed Rules will be on file with the Secretary of State, the Legislative Service Commission, and the Joint Committee on Agency Rule Review, at least thirty days prior to the public hearing, and are available at the Counselor, Social Worker & Marriage and Family Therapist Board office.
