### NOTICE OF PUBLIC HEARING OHIO EMERGENCY MEDICAL SERVICES

The Executive Director of Ohio Emergency Medical Services, with advice and counsel of the Firefighter and Fire Safety Inspector Committee, will conduct a public hearing for the purpose of soliciting comments on the following rules proposed for adoption to Chapters 4765-11 (Chartering of Firefighter and Fire Safety Inspector Training Programs), 4765-20 (Fire Service Training Programs), 4765-21 (Fire Instructor Training Programs), 4765-22 (Professional Standards), and 4765-23 (Disciplinary Actions) of the Ohio Administrative Code. These rules are being filed pursuant to a completed R.C. 119.032 five-year rule review.

Chapter 4765-11 provides definitions and referenced materials for rules pertaining to fire services, and sets forth the qualifications, course, and examination requirements for fire charter programs.

Chapter 4765-20 sets forth the qualifications and application processes for firefighter and fire safety inspector certificates.

Chapter 4765-21 sets forth the qualifications and applications processes for fire instructor, fire safety inspector instructor, and assistant fire instructor certificates.

Chapter 4765-22 sets forth professional standards for all fire service certificate holders.

Chapter 4765-23 sets forth EMS investigation and administrative action procedures.

In general, the proposed changes reorganize content of the rules for clarity and consistency, reflect changes in terminology, and address materials incorporated by reference for statutory compliance. Due to these changes, the majority of the rules are proposed for simultaneous rescission and adoption under their same rule numbers due to LSC rule-drafting requirements, which require a rule to be rescinded and adopted as new if more than fifty percent of the content is amended.

Proposed changes of a substantive nature include additional training requirements for firefighter and fire safety inspector certificates - a requirement for fire safety inspectors to complete training when a new fire code is adopted, a requirement for fire instructors and assistant fire instructors to complete training when they wish to participate in the instruction of live fire training evolutions, and a requirement for firefighters to complete training on the "Courage to be Safe, Sixteen Life Saving Initiatives;" a reduction in training hours to certify as a fire instructor or fire safety inspector instructor; increased flexibility in the delivery of fire instructor and fire safety inspector courses through optional online and distance learning, in addition to the traditional classroom setting; increased flexibility for renewal of non-affiliated and non-Ohio resident firefighter certificates; increased flexibility for the EMS Executive Director to review training for credit for Ohio certification; increased flexibility for the EMS Executive Director to accept surrender of certificates that are under investigation; the option to take continuing education courses in lieu of a reinstatement examination in specific situations; and increased authority for the Division to investigate complaints regarding examinations with or without a known complainant.
