## NOTICE OF PUBLIC HEARING

The Firefighter and Fire Safety Inspector Committee will conduct a public hearing pursuant to R.C. 119.02 through 119.04 on <u>Tuesday, December 11, 2007</u>, at 10:00 a.m. at the Ohio Department of Public Safety, Room 134, 1970 W. Broad Street, Columbus, Ohio 43223. The purpose of the hearing will be to solicit public comment on the following proposed rules to the Ohio Administrative Code:

Several rules in Chapter 4765-11 are being rescinded and filed as new rules due to an LSC rule-drafting requirement that requires an agency to rescind a rule and file it as a new rule if 50% or more of the rule is being amended.

These rules are being proposed in accordance with HB 401 (126th G.A.). This bill requires the Executive Director of the Division of EMS, with advice and counsel of the Firefighter and Fire Safety Inspector Committee, to adopt rules regarding, in general, training and education standards and certification and renewal requirements for firefighters, fire safety inspectors, fire instructors, and fire charters, as well as disciplinary guidelines and procedures for such certificate holders.

In general, the rules in **Chapter 4765-11** pertain to the application of a fire charter, criteria to obtain a fire charter, renewal and reinstatement of a fire charter, and curricula for each level of fire service training and fire service instructor training.

In general, the rules in **Chapter 4765-20** pertain to the application of a firefighter and fire safety inspector certificate, criteria to obtain each certificate, fire examinations, renewal and reinstatement of a certificate, continuing education requirements, certificate in lieu of completing a fire training program, certificates of equivalency, voluntary surrender of a certificate, and renewal requirements that current certificate holders must follow in order to obtain new certificates

within 12 months of the effective date of the rules.

In general, the rules in **Chapter 4765-21** pertain to the application of a fire instructor and fire safety inspector instructor, criteria to obtain each certificate, renewal and reinstatement of instructor certificates, assistant instructor criteria, instructor trainer criteria, and crossover certification.

In general, the rules in **Chapter 4765-22** pertain to professional standards that must be maintained by firefighters, fire safety inspectors, and instructors.

In general, the rules in **Chapter 4765-23** pertain to the investigative process, the types of disciplinary actions that can be taken against certificate holders, and the reporting requirements for such actions.

All interested parties are invited to attend the hearing and present oral and/or written testimony.
