Pursuant to section 5107.05 and Chapter 119. of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the adoption, amendment, or rescission of the rule or rules as identified below and of a public hearing thereon.

Rule 5101:1-1-50, entitled Written Declaration of Citizenship/Alien Status and the Use of the Systematic Alien Verification for Entitlements System, is being proposed for amendment, because of a five-year rule review. This rule sets forth the policy regarding written declaration for citizenship/alien status and the use of the Systematic Alien Verification of Entitlements System (SAVE) of noncitizens who apply for the Ohio Works First; Prevention, Retention, and Contingency; and Refugee Cash Assistance programs. The changes to the rule are paragraph (D) was updated to reflect there are three methods to verify documents in the SAVE system; new paragraph (D)(3) was created to include the process for a third-level review; paragraph (F) was stricken to remove the manual requirement using the G-845 form to align with federal guidance received that this process is no longer valid; and minor language changes were made to improve clarity.
