Pursuant to sections 5101.141, 5103.03, 5153.16, 5153.53 and Chapter 119. of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the adoption, amendment and rescission of the rules as identified below and of a public hearing thereon.

Rule 5101:2-42-90 entitled <u>Information to be provided to caregivers</u>, school districts and juvenile courts; information to be included in individual child care agreement, is being proposed for rescission. This rule sets forth the requirements for public children service agencies and private child placing agencies to share information about children in custody with caregivers, school districts and juvenile courts. It includes the information that must be provided in the individual child care agreement. This rule is being rescinded and will be replaced by a new rule with the same number.

Rule 5101:2-42-90 entitled <u>Information to be provided to caregivers</u>, school districts and juvenile courts; information to be included in individual child care agreement, is being proposed for adoption. This rule sets forth the requirements for public children service agencies and private child placing agencies to share information about children in custody with caregivers, school districts and juvenile courts. It includes the information that must be provided in the individual child care agreement. This rule is being proposed to replace a rule of the same number. It is substantially the same as the rule it is replacing. It has been reorganized throughout for clarity and consistency.

Rule 5101:2-47-23 entitled <u>Beginning date of reimbursability for foster care maintenance</u> is being proposed for amendment as a result of the five year rule review. This rule sets forth the beginning date of reimbursability for foster care maintenance. The changes are non-substantive and make grammatical and citation reference corrections.
