Pursuant to sections, 2151.421, 2151.429, 5153.16, 5153.166 and Chapter 119. of the Ohio Amended Code, the Director of the Ohio Department of Job and Family Services gives notice of the Department's intent to consider the amendment of the rules as identified below and of a public hearing thereon. The following rules are subject to five-year review.

OAC 5101:2-33-28 entitled "Joint planning and sharing of information among the PCSA and CDJFS" sets forth the requirements that apply to the PCSA protective supervision cases. This rule is being reviewed for the five-year review requirement. Form numbers and revision dates are being removed to be consistent with changes occurring in the case planning rules within in Chapter 38 of the Ohio administrative code with the implementation of the family case plan in SACWIS.

OAC 5101:2-38-20 entitled "Public Children Services Agencies Assessment Requirements for Child Abuse and Neglect Reports In Alternative Response" sets forth the PCSA requirements for cases receiving the provision of ongoing services within the alternative response pathway. This rule is being reviewed for the five-year review requirement. Form numbers and revision dates are being removed to be consistent with changes occurring in the case planning rules within the Chapter 38 rules of the Ohio administrative code with the implementation of the family case plan in SACWIS. The requirements of two monthly home visits and completing the case review with the family have been removed to align the rule with the minimum requirements in the traditional pathway.
