Pursuant to sections 5103.03, 5103.54, 5153.166 and Chapter 119.03 of the Ohio Revised Code, the Ohio Department of Job and Family Services gives notice of the department's intent to consider the amendment of the rules as identified below and of a public hearing thereon. The rules are being proposed as a result of five-year review.

OAC 5101:2-5-13 entitled <u>Required Agency Policies</u>, <u>Plans and Procedures</u> is being proposed for amendment as a result of the five year rule review and to update the policy regarding agency policies, plans and procedures. This rule provides guidance to agencies on the minimum required policies, plans and procedures for the agency. Paragraph (A)(1)(a) was amended to clarify the definition of prone restraint and to state that any face-down positioned restraint of a child is not permitted for any length of time. Paragraph (B) was amended for clarify.

OAC 5101:2-9-21 entitled <u>Care, Supervision and Discipline</u> is being proposed for amendment as a result of the five year rule review. This rule provides guidance to residential facilities regarding the care, supervision and discipline of the children in the facility. The title of the rule is changing to Residential Care, Supervision and Discipline. Paragraph (B) was broken out for clarity. Paragraph (C) removed the language clarified in paragraph (B) and in paragraph (C)(19) The definition for prone restraint has been revised to change the language prohibiting any method of intervention where a person's face and/or frontal part of the body is placed in a downward position touching any surface for any amount of time.
