Pursuant to section 5103.03, 5103.0316, 5153.166 and Chapter 119. of the Ohio Revised Code, the Ohio Department of Job and Family Services gives notice of the department's intent to consider the adoption, amendment, or rescission of the rule or rules as identified below and of a public hearing thereon.

Rule 5101:2-5-40, entitled Preplacement and continuing training programs, is proposed for amendment as a result of the five-year rule review. This rule provides guidance to agencies seeking to operate a preplacement training program or a continuing training program. This rule is amended to remove the requirement of the annual submission of agency training plans and was replaced to require training plans only when there is a new plan or changes to existing plans.

Rule 5101:2-9-02, entitled Staffing requirements, is proposed for amendment as a result of the five year rule review, and rule writing authority to amend, rescind or create new rules to provide guidance to licensed providers. The rule contains guidance on staffing requirements in a residential facility. The proposed amendment to this rule removes twenty hours of training before staff can be unsupervised with minor residents in the facility.

Rule 5101:2-42-65, entitled Caseworker visits and contacts with children in substitute care, is being amended for the five year rule review and rule writing authority to amend, rescind or create new rules to provide guidance to licensed providers. This rule provides guidance to agencies regarding caseworker visits and contacts with the child and the substitute caregiver(s). Language requiring weekly contact with caregivers for children placed in special, exceptional, or intensive needs placements is being removed.

Rule 5101:2-42-66.1, entitled Comprehensive health care for children in placement, is proposed for amendment as a result of the five-year rule review. This rule guidelines for the public children service agencies (PCSAs) and private child placing agencies (PCPAs) on the coordination and prevision of health care for each child in the agency's care or in the custody, placed into substitute care. Paragraph (C) was amended to remove restrictive language regarding medical screenings when a child's placement changes or when a child

is placed into foster care directly from a medical setting.
