

**FEDERAL MEDICAID NOTICE AND PUBLIC HEARING NOTICE

Pursuant to section 5111.873, 5111.85 and Chapter 119. of the Ohio Revised Code, and 42 C.F.R. 447.205, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the rescission and adoption of the rules as identified below and of a public hearing thereon.

**Rule 5101:3-41-15**, entitled **Home and community based waiver services-reimbursement for adult day support, vocational habilitation, supported employment-enclave, supported employment-community, supported employment adaptive equipment and non-medical transportation to access one or more of these services administered by the Ohio department of mental retardation and developmental disabilities.** This rule establishes the payment standards governing reimbursement for adult day support, vocational habilitation, supported employment-enclave, supported employment-community, supported employment adaptive equipment and non-medical transportation to access one or more of these services as components of the Medicaid program and as administered by the Ohio Department of Developmental Disabilities (DODD). This rule is being proposed for rescission and a new rule under the same number is being proposed for adoption.

**Rule 5101:3-41-15:** entitled **Home and community based waiver services-reimbursement for adult day services as administered by the department of developmental disabilities.** This rule authorizes the reimbursement for adult day services as a component of the Medicaid program and as administered by the Ohio Department of Developmental Disabilities (DODD). This rule is replacing the rescinded rule of the same number.

The Department of Developmental Disabilities (DODD) revised various rules governing the adult day services program under Medicaid waivers to restructure training requirements for providers of adult day services and to increase the Supported Employment- Community payment rate. The ODJFS authorization rule will be in alignment with the proposed changes. The DODD estimates that the implementation of the proposed Supported Employment-Community rate increase will result in approximately \$191,000 in non-federal share during SFY 2013 for County Boards of Developmental Disabilities.
