Pursuant to sections 5111.873 and Chapter 119. of the Ohio Revised Code and 42 C.F.R. 447.205, the director of the Office of Medical Assistance gives notice of the department's intent to consider the adoption and rescission of the rules as identified below and of a public hearing thereon.

**5101:3-41-21 Medicaid home and community-based services program-transitions developmental disabilities waiver.** This rule authorizes various rules governing the Transitions Developmental Disabilities waiver, a component of the Medicaid home and community-based services program pursuant to sections 5111.85 and 5111.87 of the Revised Code. This rule is being proposed as a new rule.

**5101:3-41-22 Transitions developmental disabilities - payment standards.** This rule defines the terms used for billing and calculating rates for the Transitions Developmental Disabilities waiver. This rule is being proposed as a new rule.

**Rule 5101:3-47-02 Transitions MR/DD waiver consumer eligibility for enrollment.** This rule defines how individuals become eligible and maintain eligibility for the Transitions Developmental Disabilities waiver. This rule is being proposed as a rescinded rule.

**Rule 5101:3-47-02.1 Transitions MR/DD waiver: eligibility criteria for time-limited Enrollment of HOME choice (Helping Ohioans Move, Expanding Choice) demonstration program participants.** This rule sets forth the eligibility criteria when an individual is enrolled on the Home Choice program. This rule is being proposed as a rescinded rule.

**Rule 5101:3-47-04 Transitions DD waiver: definitions of the covered services and provider requirements and specifications.** This rule sets forth the definitions of services covered by the Transitions Developmental and Disabilities waiver and provider requirements and specifications for the delivery of Transitions Developmental Disabilities waiver services. This rule is being proposed as a rescinded rule.

**Rule 5101:3-47-05 Transitions MR/DD waiver program: calculation of individual cost cap.** This rule sets forth the calculation of the individual cost cap for individuals enrolled on the Transitions Developmental Disabilities waiver program. This rule is being proposed as a rescinded rule.

**Rule 5101:3-47-06 Transitions DD waiver program: reimbursement rates and billing procedures.** This rule defines the terms used for billing and calculating rates for services under the Transitions Developmental Disabilities waiver program. This rule is being proposed as a rescinded rule.

Section 5111.871 of the Ohio Revised Code requires that the Office of Medical Assistance transfer the Transitions Developmental waiver program to the Department of Developmental Disabilities (DODD). The aforementioned rules will permit the daily administrative functions of the waiver to be transferred to the DODD.
