Pursuant to Section 5111.02 and Chapter 119. of the Ohio Revised Code and 42 CFR 447.205, the director of the Department of Job and Family Services gives notice of the department's intent to amend rules: 5101:3-4-06 and 5101:3-4-17 on an emergency and permanent basis and of a public hearing upon the permanent amendment.

Rule 51013-4-06 entitled <u>Physician visits</u> outlines coverage provisions for all visit services. It is being amended on an emergency basis to be effective on or about January 1, 2005, and proposed for permanent amendment to incorporate coding changes instituted by the American Medical Association in its 2005 Current Procedural Terminology book. The description of the pediatric and neonatal critical care codes 99293 and 99296 have been revised to change the definition of a critically ill infant to 29 days through 24 months of age from 31 days up through 24 months of age and the definition of a critically ill neonate to 28 days of age or less from 30 days of age or less. The Department estimates that there is no fiscal impact resulting from these changes.

Rule 5101:3-4-17 entitled <u>Gastroenterology</u>, <u>otorhinolaryngology</u>, <u>endocrinology</u>, <u>neurology</u>, <u>and special dermatology services</u> outlines coverage provisions for these services provided by physician providers of Medicaid services. It is being amended on an emergency basis to be effective on or about January 1, 2005, and proposed for permanent amendment to incorporate coding changes instituted by the American Medical Association in its 2005 Current Procedural Terminology book. The following new evaluative and therapeutic services codes have been added: 92620, 92621, and 92625. Audiologic function test code 92589 has been deleted. The Department estimates that there is no fiscal impact resulting from these changes.
