Pursuant to section 5111 and Chapter 119 of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the rescission and adoption of rules 5101:3-40-01 and 5101:3-43-01 and adoption of 5101:3-44-01 as identified below and of a public hearing thereon.

Rule 5101:3-40-01, entitled home and community-based services waiver VI program is proposed for rescission and new rule 5101:3-40-01, entitled Medicaid home and community-based services program- individual options waiver is proposed for adoption. The adoption of this rule will add day habilitation services to the Individual Options waiver benefit package effective 7/1/05, consistent with proposed federal waiver amendments. It authorizes rules promulgated by ODMRDD, which administers the program pursuant to an Interagency Agreement with ODJFS. The proposed rule specifies eligibility, enrollment, disenrollment, prior authorization, available services, service plan requirements and payment standards for the Individual Options waiver program.

Rule 5101:3-43-01, entitled Home and community-based services: residential facility waiver is proposed for rescission consistent with termination of the federal medicaid waiver on June 30, 2005. Rule 5101:3-43-01 Home and community-based services program: residential facility waiver program termination and reimbursement standards is proposed for adoption in order to establish standards for payment of claims subject to reimbursement pursuant to section 5111.02 of the Revised Code.

Rule 5101:3-44-01, entitled Home and community-based services program- Community Access Model Waiver, is proposed for adoption to establish the Community Access Model (CAM) waiver as a component part of the medicaid program adminstered by the department of mental retardation and developmental disabilities pursuant to an Interagency Agreement with ODJFS. The rule specifies eligibility, enrollment, disenrollment, prior authorization, available services, service plan requirements and payment standards for the CAM waiver program.
