The replacement rule is identical to the current rule with two additions: 1) inclusion of provisions for the use of interactive videoconferencing; and 2) inclusion of marriage and family therapists and independent marriage and family therapists as professionals able to provide and/or supervise the service.

## 5122-29-05 <u>Pharmacologic Management Service</u>.

The current rule, which was effective March 25, 2004 is being rescinded and replaced. The replacement rule is identical to the current rule with one addition: inclusion of provisions for the use of interactive videoconferencing.

# 5122-29-17 <u>Community Psychiatric Supportive Treatment (CPST) Service.</u>

Adds marriage and family therapists and independent marriage and family therapists as professionals able to provide and/or supervise the service.

## 5122-29-19 Consultation Service.

Adds marriage and family therapists and independent marriage and family therapists as professionals able to provide and/or supervise the service.

#### 5122-29-20 Prevention Service.

Adds marriage and family therapists and independent marriage and family therapists as professionals able to provide and/or supervise the service.

#### 5122-29-21 Mental Health Education Service.

Adds marriage and family therapists and independent marriage and family therapists as professionals able to provide and/or supervise the service.

### 5122-29-23 Adjunctive Therapy Service.

Adds marriage and family therapists and independent marriage and family therapists as professionals able to provide and/or supervise the service.
