#### 5122-24-01 Definitions

Corrects cites to the Administrative Code in paragraphs (B)(85) and (B)(86) and adds the definition of "Social Worker Trainee".

### 5122-25-02 <u>Accreditation Requirements</u>

Amplifies the rule that requires agencies to report their accreditation survey dates.

## 5122-29-10 <u>Crisis Intervention Mental Health Service</u>

Clarifies in paragraph (B)(1) that the elements enumerated in that paragraph shall be provided either directly by the agency seeking certification for this service or through a contract with an agency already ODMH certified for the service.

Adds Social Worker Trainees to each of these rules' list of eligible service providers:
