Rule 5160-2-07.8, entitled <u>Redetermination of prospective payment rates</u>, is being proposed for rescission as a result of five-year rule review. This rule sets forth the methodology for the redetermination of prospective payment rates. This rule has been replaced by rule 5160-2-65.

Rule 5160-2-07.11, entitled <u>Payment methodology</u>, is being proposed for rescission as a result of five-year rule review. This rule sets forth the payment methodology policies for hospitals. This rule has been replaced by rule 5160-2-65.
