Pursuant to Chapter 119. and section 5166.02 of the Revised Code, the Director of the Ohio Department of Medicaid (ODM) gives notice of ODM's intent to consider the amendment of the rules identified below and of a public hearing thereon.

OAC 5160-33-02, entitled "Definitions for the assisted living home and community based services waiver (HCBS) program," is the rule that sets forth the definitions used in the Assisted Living HCBS waiver program rules. This rule will be proposed for amendment pursuant to five-year rule review including update to definitions to align with other rules, removal of definitions that are no longer utilized throughout 5160-33 of the OAC rules, references to Revised Codes added, sentence structure changes, update to effective dates for statutory citations and removal of citation for an administrative code that no longer applies. Also Am. Sub. H. B. 166 (133rd G. A.) lists six terms that cause a rule to be deemed to contain regulatory restrictions: 'shall', 'shall not', 'must', 'may not', forms of 'require', and forms of 'prohibit'. All of these terms have been removed and the passages in which they appeared have been recast.

OAC 5160-33-05, entitled "Provider conditions of participation for the assisted living home and community based services (HCBS) waiver program," is the rule that sets forth the conditions under which providers are able to participate in the assisted living home and community based services waiver program. This rule will be proposed for amendment pursuant to five-year rule review including modification to the title of the rule, sentence structure changes, update an administrative code reference and update to effective dates for statutory citations. Also Am. Sub. H. B. 166 (133rd G. A.) lists six terms that cause a rule to be deemed to contain regulatory restrictions: 'shall', 'shall not', 'must', 'may not', forms of 'require', and forms of 'prohibit'. All of these terms have been removed and the passages in which they appeared have been recast.

OAC 5160-33-06, entitled "Covered services for the assisted living services home and community based services (HCBS) waiver program," is the rule that sets forth the services covered by the assisted living home and community based services waiver program. This rule will be proposed for amendment pursuant to five-year rule review including sentence structure changes.

ODM will hold the public hearing for this rule package via teleconference and in-person. All inperson attendees are required to follow Lazarus building COVID-19 safety protocols when inside the ODM office. ODM will not require masks for individuals entering the building. However, visitors are welcome to wear masks if that is their preference. Masks are encouraged if visitors are not up to date with vaccine and boosters, have an immune disorder, or chronic medical condition(s). ODM encourages social distancing in all areas of the office. The date and time for the public hearing are listed at the top of this Notice as well as the phone number, PIN (access code), and link for teleconference attendance, and location for in-person attendance.

All interested parties are invited to participate in the public hearing. Both oral and written testimony will be accepted for this hearing and will be given the same consideration. Persons who want to give oral testimony are asked to send a message by e-mail to <u>Rules@medicaid.ohio.gov</u> no later than one hour before the hearing to be added to the witness list. Those attending in person can be added to the witness list at the hearing. There will be a final call at the end of the hearing for persons who wish to offer oral testimony but are not yet on the witness list.

Written comments submitted in-person, by e-mail, postal mail, or fax that are received or postmarked no later than the day of the hearing will be accepted as testimony and will become part of the hearing record. All testimony will become public record; therefore, ODM asks that protected health information (PHI) be excluded unless the information belongs to the person submitting the testimony orto a person for which the submitter is a legal guardian. Written testimony sent by e-mail is highly recommended. All persons who submit testimony by e-mail will be sent a confirmation of receipt.
